TOGETHER WE LEAD

On November 8, 2023, with over 300 local leaders in attendance, a ceremonial ribbon-cutting, marked the inauguration of the state-of-the-art, world-class Memorial Cancer Institute, located next to Memorial Hospital West.

The four-story, 125,000-square-foot institute features a dedicated breast cancer center designed with input from survivors. It has 63 exam rooms, 51 private infusion suites, a rooftop garden and a meditation sanctuary.

The facility, which cost \$125 million, stands as a testament to the community's commitment to advancing cancer care. Generous donations to the Memorial Foundation contributed to this project, including those from AutoNation, Florida Community Health Network, Rance King Properties, Inc., Pink Angels of Memorial Foundation, and Domenica (Sundaye) & Louis DeLuca Trust.

The Memorial Cancer Institute is expected to serve nearly 5,000 patients annually.

Life-Saving Family Care

Heather was born with a congenital heart condition called tetralogy of Fallot, which affects blood flow to the heart.

When Heather became pregnant the first time, she was considered a high-risk pregnancy due to her heart condition and was followed by the Maternal Fetal Medicine team.

Then she began coughing up blood. Thoracic surgeons from Memorial Cardiac and Vascular Institute performed surgery to remove part of her lungs, resolving the problem for the duration of the pregnancy.

When Heather became pregnant again, the problem returned. During a bronchoscopy to look at her lungs, Heather began bleeding. Luckily, her multidisciplinary team leaped into action.

Within a minute, the obstetrician performed a cesarean section. As soon as the baby was delivered, the extracorporeal membrane oxygenation (ECMO) team connected Heather to life-saving treatment that would take over for her lungs so they could rest and heal.

Heather remained on ECMO for a few days under the care of cardiac, thoracic and ECMO teams. Her daughter, Lily, was cared for in the Joe DiMaggio Children's Hospital Wasie Neonatal Intensive Care Unit, just like her older brother had been, and received care from a team of pediatric specialists.

"It was nice to have everyone here, to help me but my children as well," Heather says. "They're an amazing team. For them to have my back was a great relief. It was nice to know they were looking out for me and for my family."

Devan is "thriving" now, but that certainly wasn't always the case. Born with a rare heart defect, lungs that didn't fully develop, a backwards intestinal tract, and missing a spleen – all the result of genetic microdeletion syndrome – it had been a moment-to-moment existence for the child and his parents, Rajesh and Jignasha, in the first year of Devan's life.

"My son was very near death on at least nine occasions and his most recent surgery lasted eleven hours," said Rajesh, a Parkland resident. "But the multi-disciplinary care he received from the specialists and their teams at Joe DiMaggio Children's Hospital gave him an opportunity to survive, and he's now developing as an almost 18-month-old should."

Devan was hospitalized for months after his birth in 2022, and his parents spent that time living at the Conine Clubhouse in Hollywood, a hotel-like facility where families can stay for free while their child is being treated at the children's hospital next door. "With our son's condition so tenuous, having the clubhouse available to us was a godsend. We were able to get some rest and still be at his bedside in minutes when there was an emergency. It made all the difference for us."

While Devan will most likely need at least one more open-heart surgery as he grows, he's doing well now, with appropriate energy and activity levels that have him making strides in the therapy he receives. Doctors predict that Devan's next procedure will be necessary within two to five years, and his family will once again have access to the facility that local philanthropy makes possible.

"The Conine Clubhouse is an extraordinary place, and we're eternally indebted to everyone that makes it possible for families like ours."

The JDCH Foundation funds the annual operations of the Conine Clubhouse through the Conine All-Star Golf Classic and other fundraising initiatives.

Community Foundation of Broward

The Community Foundation of Broward has been a philanthropic supporter of Memorial and Joe DiMaggio Children's Hospital Foundations for almost 3 decades. Through competitive grant awards as well as donor directed funds, their support has covered a wide range of needs including cancer patient emergency support, behavioral health, cardiology, orthopedics and much more.

In 2023, support from Community Foundation of Broward totaled over \$300,000. Through a donor advised fund, they have provided support to our Level IV neonatal intensive care unit which cares for approximately 1,000 newborn babies each year who need a specialized level of attention because they were born premature, have infections, low blood sugar, congenital anomalies, or experience other complications at birth which often require an extended length of stay. We are also in the second year of a 3-year grant for cancer research which is supporting our collaboration between Florida Atlantic University and Memorial Cancer Institute as we establish the first minority biorepository in the state of Florida. In addition, Community Foundation of Broward grants are supporting Memorial community programs to reduce isolation for seniors and improve their mental health and wellbeing.

Co-emceed by Dina B. from 99.9 Kiss Country and current patient, Max, over 1,000 guests enjoyed a craft cocktail reception, a spectacular silent auction, a lavish dinner, an energy-filled live auction, and then danced the night away with Hollywood U2- World's Greatest U2 Tribute Show. For the first time in the history of the Ball, the million dollar mark was hit, in record-setting fashion, raising over \$1.3 million for the children and families of Joe DiMaggio Children's Hospital.



The **CONINE COMMITTEE** is one of Joe DiMaggio Children's Hospital Foundation's longest standing fundraising groups. For nearly three decades, they have organized and implemented fundraising events, including the Conine All-Star Golf Classic and the Jeff Conine Celebrity Poker Classic. To date, these events have raised more than \$8 million dollars to fund the annual operating expenses of the Conine Clubhouse, a home-away-from-home to over 25,000 families with free-of-charge services while their child is a patient at Joe DiMaggio Children's Hospital. In 2023, the 29th Annual Conine All-Star Golf Classic hosted a tournament high of 208 players and raised a record-setting \$425,000.

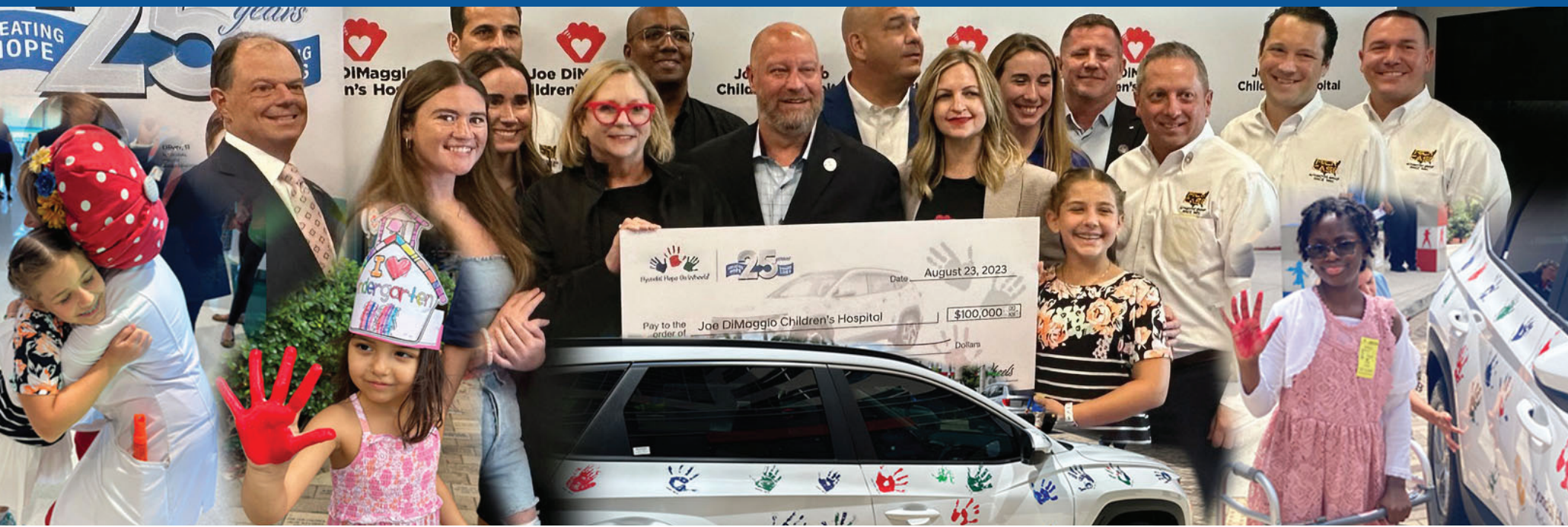
16 Years | \$1.1 Million for Joe DiMaggio Children's Hospital

Established in 1998, *Hyundai Hope On Wheels* was inspired by a group of New England Hyundai dealers with the goal to end childhood cancer. Twenty-five years later, *Hyundai Hope On Wheels* has become one of the nation's leading funders of pediatric cancer research. To date, *Hyundai Hope On Wheels* has supported nearly 1,300 cancer research studies at over 175 medical institutions.

In 2023, *Hyundai Hope On Wheels* presented a total of 88 grants to institutions across the U.S. that are focused on improving outcomes and treatments for children diagnosed with cancer, including (18) \$400k Hyundai Scholar Hope Grants, (18) \$250k Hyundai Young Investigator Grants, and (52) \$100k Hyundai Impact Grants.

Since 2008, Joe DiMaggio Children's Hospital has been a recipient of over \$1.1 million dollars inclusive of the Hyundai Scholar Hope Grants and the Hyundai Impact Awards, thanks to the support of South Florida Hyundai dealers, including the Rick Case Automotive Group.
